

2020 ENVIRONMENTAL PERFORMANCE COMMUNICATION TO INTERESTED PARTIES

Madrid, January 31th, 2020

As a business trend in environmental matters and sustainability, AUXITEC has the following commitments:

- ✓ Our projects include considerations of improvement or mitigation of the environmental impact, their authors consider a product life cycle perspective that they carry out.
- ✓ We reduce as much as possible the consumption of plastics, mainly in the dining room by providing workers with utensils of other alternative materials (for example: ceramics, glass, metal, etc).
- ✓ We collaborate with our suppliers in improving their processes to mitigate the environmental impacts associated with them, indicating operational action measures.
- ✓ We advise our clients on the environmental improvement of their projects, by incorporating alternative measures in technical solutions.
- ✓ We carry out environmental awareness campaigns through informational posters in our facilities (for example: proper use of air conditioning according to legal temperature limits).

In addition, AUXITEC has implemented an integrated management system based on ISO 9001: 2015 and ISO 14001: 2015 standards in which the life cycle of the products / services we provide is taken into account. This implies:

- ✓ Review of compliance with environmental legislation:
We apply a systematic (semi-annual) to update and evaluate the environmental legal requirements applicable to our company.
- ✓ Aspectos Environmental aspects and objectives:
AUXITEC annually carries out an identification and evaluation of environmental aspects associated with our activities.

This identification has been revised as of January 2020, obtaining the following aspect with a significant result:

- **Paper Consumption.**

The consumption of 2019 has risen by 3.7% compared to those of 2018.

The 2020 target is set to reduce paper consumption by 4% compared to the previous year.

- ✓ **Operational Control:**

- We ensure the proper functioning and maintenance of our facilities and buildings through the appropriate operational control.
- We make a correct management of the generated waste.

- ✓ **Internal Training**

All new staff at AUXITEC receive specific training related to the environment through a Manual of Good Environmental Practices.

- ✓ **Planning and response to environmental emergencies**

Annually, and with the objective of validating the planning and response to environmental emergencies and ensuring their adequate knowledge by the workers, a practical simulation is carried out so that the staff knows firsthand how to act in case of environmental emergencies.

- ✓ **Other Considerations:**

- Internal environmental audits are planned and performed to ensure compliance with system requirements.
- If any type of environmental accident occurs, environmental emergency protocols will be implemented.
